On September 2, 2015 at approximately 20:53 Hrs. deputies with the Henry County Sheriff's Office were dispatched to Co. Rd. S3, near Co. Rd. 4, in Washington Twp., in Henry County, Ohio for a reported drive by shooting. The caller and victim advised he was running west on Co. Rd. S3, on the south side of the road, near Twp Rd. 3B. The victim stated he heard what he thought was two firework going off behind him, and when he turned to look he saw a silver Honda Civic driving westbound approximately 15 feet behind him. He then saw the muzzle flash of a firearm come from the driver's seat of the vehicle. The car was directly across from the victim at this time, and the victim turned away and ducked. As he looked back he saw more flashes and described the

muzzle flash as a two or three inch long flash of fire, that was pointed directly at him. The victim stated he counted seven or eight shots, and could see the barrel of a firearm sticking out of the car when it passed him. The car went down the road, turned around and then went south on Rd 4. The road is a dead end road, and the victim later saw the vehicle travel back north on Rd 4. The victim advised he recognized the car and believed it was his neighbor's vehicle, as they own one identical to what was used during the offense.

Upon arrival at the defendant's residence, the defendant was found outside near the driveway. The defendant was seen dropping something near a tree, which was later found and identified as the key to a Honda Civic. In the driveway of the residence, a silver Honda Civic was located, and the hood was felt and found to be very warm to the touch. To the south of the car, a .45 caliber handgun was located under a tree. It was found with the hammer locked back, and when the handgun was secured the magazine and chamber were found to be empty. The gun smelled as it had been recently fired, and the magazine holds seven cartridges fully loaded. At the dead end on Rd 4, seven .45 caliber empty casings were located.

The defendant did, in Washington Twp., Henry County, Ohio, cause or attempt to cause physical harm to another by means of a deadly weapon, which was discharged from a motor vehicle.

On September 2, 2015 at approximately 20:53 Hrs. deputies with the Henry County Sheriff's Office were dispatched to Co. Rd. S3, near Co. Rd. 4, in Washington Twp., in Henry County, Ohio for a reported drive by shooting. The caller, Kyle Kern, advised he was running on Co Rd S3, in between Rd 3 and Rd 4 when a car drove by him and shot at him. Kyle stated it was a silver Honda Civic, and believed it to be his neighbor's car, Craig Parsons. Kyle also stated the car was westbound on Rd S3, and then turned south on Rd 4. He later saw the car go back north on Rd 4.

Upon arrival on Rd S3 I located Kyle at a residence. Kyle began to describe the events that took place. He advised he was running west on Rd S3, and was on the south side of the road. As he approached Twp Rd 3B, he heard what he thought was two fireworks go off directly behind him. When he turned to look he saw a silver Honda Civic driving westbound approximately 15 feet behind him. He then saw the muzzle flash of a firearm come from the driver's seat of the vehicle. The car was directly across from him at this time, and Kyle turned away and ducked away from the car. As he looked back he saw more flashes and described the muzzle flash as a two or three inch long flash of fire, that was pointed directly at him. Kyle stated he counted seven or eight shots, and could see the barrel of a firearm sticking out of the car when it passed him. The car went down the road, turned around, and then went south on Rd 4. The road is a dead end road, and 30-45 seconds later he saw the vehicle travel back north on Rd 4. Kyle advised he recognized the car and believed it was his Parson's vehicle, as they own one identical to what he saw.

While waiting for Sheriff Bodenbender to arrived on scene, I briefly looked for empty casing on the roadway and was unable to locate any. When Sheriff Bodenbender arrived on scene, the decision was made check the Parson's house for the vehicle, as a passer by stated he saw a silver car in the driveway with all four doors open.

Upon arrival at the Parson's residence, Sheriff Bodenbender was first into the driveway. I then saw a person that appeared to be Cullen walking across the drive in front of the Sheriff's patrol car. I exited my car and as I approached the person, Sheriff Bodenbender was ordering him to the ground. The person was identified as Cullen, and as he went to the ground on his own power, the Sheriff saw him dropped something by a tree. Cullen currently had a beer bottle in his hand, along with a phone/ipod. Cullen had a pocket knife in his back pocket that was secured. The item he dropped was found under a pine tree and it was a car key for a Honda, presumable belonging to the silver Honda Civic in the driveway. Sheriff Bodenbender searched and secured Cullen, and Deputy Birtcher arrived on scene. Deputy Birtcher assisted Sheriff Bodenbender with handcuffing Cullen, while I checked the Honda Civic. The car's hood was felt and it was very warm to the touch. There were two other cars in the driveway and their hoods were felt as well for comparison. The Honda Civic's hood was the warmest hood of the three vehicle. At this time Cullen was placed in Deputy Birtcher's car, and he was advised by Sheriff Bodenbender he was under arrest for Felonious assault, and advised his Miranda rights by Deputy Birtcher.

The next available tow was called (Gunn's Towing) for the vehicle. While checking the surrounding area for additional evidence, Craig and Michelle came outside and asked what was going on. Sheriff Bodenbender informed them what happened tonight, and Craig and Michelle advised they would not answer any questions or assist with the investigation.

While checking the area, I located a handgun under a pine tree directly to the south of the car. The handgun was found with the hammer locked back. The handgun was secured, photographed, and taken for evidence. The magazine and chamber were found to be empty. Cullen was transported back to the Sheriff's Office by Deputy Birtcher. Gunn's Towing transported the car to the impound lot, where it currently sits as a search warrant is

prepared for the vehicle. A search warrant was obtained for Cullen's blood, as it was believed he was under the influence of alcoholic or drugs or both at the time of the offence.

Kyle was called back to the scene on Rd S3 to show where the shooting took place, and to obtain a digital statement. Deputy Glanz and K9 Andy were called out to Co Rd S3 to search for the shell casings. S3 was checked and none were found. We then went to Rd 4 where it dead-ends. K9 Andy showed interest in one area of the cul-de-sac, and seven .45 caliber shell casings were found. The casings were photographed and collected for evidence.

Back at the office the handgun was examined and found to be a Regent R100 in .45 caliber. The gun appeared and smelled like it was fired recently, as the end of the muzzle appeared dirty or covered with burnt and unburned gun powder. The handgun, shell casings and other evidence were secured and logged into the temporary evidence locker. They were then transported to BCI by Chief Deputy Cohrs.

Deputies were dispatched to Co Rd S3 between Co Rd 3/Co Rd 4 for a subject that was out jogging and got shot at by his neighbor. Dispatch then advised that the caller stated that he recognized the vehicle as belonging to his neighbor's, the Parsons, and that 7-8 shots were fired at him out of the vehicle.

While this Deputy was en route Deputy Saneholtz and Sheriff Bodenbender were out speaking with the caller, Kyle Kern. Deputy Saneholtz then advised this Deputy that the vehicle involved is a silver Honda Civic. As this Deputy was about 2 miles away Deputy Saneholtz and Sheriff Bodenbender advised that they were at the Parson's residence, S-971 Co Rd 4, and this Deputy arrived there within a couple of minutes. When this Deputy arrived Sheriff Bodenbender had Cullen Parson's detained and advised this Deputy to take him into custody. Cullen was taken into custody by this Deputy and placed in my patrol car. Cullen was then read his Miranda Warning and he advised he understood. This Deputy then returned to Sheriff Bodenbender and he then advised of several items that he recovered from Cullen. Sheriff Bodenbender advised that when he got out of his patrol car Cullen was seen throwing a key under the tree. Sheriff then handed the key, a Honda car key, to this Deputy and it was placed in an evidence bag. Sheriff then handed this Deputy several other items that were taken off Cullen and were placed in evidence bags by this Deputy. The items were \$870.00 in cash(41 \$20 dollar bills and 1 \$50 dollar bill), a Gerber pocket knife and Motorola Droid cell phone and headphones. All evidence was later logged into evidence and place in the temporary evidence lockers at the Sheriff's Office. Sheriff Bodenbender also advised that Cullen had an open Budweiser beer bottle in his hand when Deputies arrived. This Deputy then went back to the patrol car and spoke to Cullen. Cullen was noticeably intoxicated and a strong odor of an alcoholic beverage was coming from his persons. Cullen was reminded of his rights and advised he did not do anything and had been home all night. Cullen was then advised he was in custody for Felonious Assault and he advised he did not want to speak to this Deputy any further.

This Deputy also saw the car that was described as the vehicle used in the shooting and the vehicle was felt and was warm to the touch. While Sheriff Bodenbender, Deputy Saneholtz and this Deputy were explaining to Cullen's parents what had taken place Deputy Saneholtz shined his light under a tree in front of the vehicle and noticed a black pistol laying under the tree. The firearm was photographed and collected as evidence by Deputy Saneholtz. Deputy Saneholtz also photographed the vehicle and a wrecker was called to remove the vehicle. Gunn's Towing arrived a short time later and the vehicle was removed and taken to the county impound. A search warrant will be applied for to search the vehicle as the owner would not allow Deputies to search the vehicle.

This Deputy then transported Cullen to the Sheriff's Office. Cullen was then asked if he would submit to a Blood Alcohol test and a Gun Shot Residue test and he advised that he would not submit to one. At this time Prosecutor Hawken and Hannah were contacted and advised of the complaint. Prosecutor Hawken then started working on a search warrant for a blood alcohol test and as Cullen was intoxicated and was believed to have fired the gun while intoxicated. While this Deputy was at the office Cullen started to argue with this Deputy so he was placed in the jail cell. A short time later Cullen could be heard yelling from the cell and dispatcher Lynne advised that he could see Cullen hitting his head on the cell bars on the camera. The search warrant for a blood draw alcohol test was then completed by Prosecutor Hawken and this Deputy got the warrant and went to Judge Rosebrook's residence where the warrant was signed. On 09-02-15 at approximately 10:20pm this officer was contacted by Deputy Saneholtz regarding what had been reported and taken place. This officer then called and spoke with Sheriff Bodenbender. It was decided to call out Deputy Glanz and the Sheriff K-9 for an article search of the area in attempt to locate any spent shell casing. This officer then came on duty and drove to the location of the offense along CO RD S3. Upon my arrival Deputy Glanz, Deputy Saneholtz and the victim were on scene.

This officer then left that location and drove to the cul-de-sac on CO RD 4 south of CO RD S3. It was reported that after the shots were fired, the victim observed the vehicle drive down to the area of the cul-de-sac and remain there for thirty to forty-five seconds before driving back north on CO RD 4. This officer stood by at that location until Deputy Glanz arrived. Upon his arrival the Sheriff K-9 was deployed to conduct an article search of the area. As the K-9 was searching he was observed showing great interest to the west side of the cul-de-sac on the pavement. This officer walked to that location and observed several spent shell casings laying on the pavement. Deputy Glanz further inspected the casings without touching or moving them and found that they were .45 caliber. It was previously reported to this officer by Deputy Saneholtz that the firearm that they had recovered from the Parsons' yard was a .45 caliber pistol.

Upon arrival I spoke with Deputy Saneholtz and Kyle Kern who gave me the general area of this occurrence as the south side of Rd S3 approximately 25-75 yards east of Rd 3B. K9 Andy was deployed and walked up and down the south side of Rd S3 in this area several times but failed to locate any shell casings. I attempted to have Andy enter the bean field but he was not able to walk through the beans which were just about waist high on me.

Next I responded to the culdesac of Rd 4 on the north side of US RT 24 where Sgt Walker was standing by securing the scene. He advised that the vehicle looked like the one that Cullen Parsons drives and that the subject through a bottle of Budweiser beer out the window that hit the road and went into his yard. Charles was asked if he saw Cullen driving the vehicle and he advised that he did not see who it was and only knew that Cullen drove a vehicle similar to the one that went by. During the conversation Rolando had with Cullen, Rolando stated Cullen said that he got "fucked up" and was driving around and seen some random person and he wanted to try out his gun, and he just started shooting at that jogger. Over the past two weeks I have been in contact with Kevin Carpenter regarding a possible search of the field where the shooting took place. Kevin metal detects for a hobby, and he advised he would be willing to search the area at a later time. On today's date, Kevin and his brother Randy met at the field and began to metal detect the area. They started around 09:30 Hrs. and around 11:00 Hrs. I check their progress. At this time they did not locate anything, other than cans.

At approximately 12:00 Hrs. I was contacted by Kevin and he advised he located one bullet. I arrived back out at the location, and Kevin stated he was detecting an area near the field's edge and got a reading on the metal detector. He looked on the ground and saw a bullet. He placed a flag next to the bullet and called me. The bullet appeared to be a copper plated .45 caliber bullet. The bullet was photographed, and collected for evidence along with the dirt the bullet was fond on. I also measured the location of the bullet, using a concrete post next to the road as my reference point, and the south side of the road as my base line. The bullet was found to be approximately 7'11" to the west of the reference point along the base line, and 136'1" south of the base line. The nose of the bullet was found to be facing northwest, with the base of the bullet pointing to the southeast. When the shooing took place, the beans in the field were still up, and could have caused the bullet to tumble end-over-end until it came to rest on the top of the dirt. Randy and Kevin provided written statements of what they saw and did up to when they located the bullet. The bullet will be logged into the temporary evidence locker, and will be sent to BCI for comparison.
