13 Q DEPUTY SANEHOLTZ: Okay today's date is
14 Friday, September 18th, 2015. It's roughly 15:35
15 hours. This is Ross Saneholtz speaking. We're
16 out at CCNO.

17 I'm with ...

18 BY DEPUTY SANEHOLTZ:

19 Q Can you state your name and date of birth for me.
20 A Rolando Valle, 12-4, 1979.
21 Q And it was brought to my attention that you had some
22 information on an ongoing investigation. If you just would want
23 to start off with what that information is about and who it is
24 and your relationship to him.

1 A Just a cell mate, Collin Parsons, D M Block.
 2 Q Okay. What date were you having the conversation with
 3 him?
 4 A Last week sometime.
 5 Q Roughly Monday, Tuesday, something like that or like --
 6 A Yeah.
 7 Q -- a Monday or Tuesday?
 8 A Right.
 9 Q Okay, just middle of the day probably?
 10 A Yeah.
 11 Q Okay. So Monday or Tuesday of last week you were
 12 talking to him. What was that conversation about?
 13 A About him going off and shooting at that jogger.
 14 Q Okay.
 15 A That was running off.
 16 Q Right.
 17 A He said he was all drunk, shot at him.
 18 Q Okay, and to the best of what you can recall, how did
 19 that conversation start? I mean were you guys talking about the
 20 weather, sports --
 21 A Talking about weapons.
 22 Q What type of weapons?
 23 A Just guns, you know, type of Glocks and stuff like
 24 that.

1 A No.
 2 Q Did he tell you what he used for a gun to shoot?
 3 A I thought he said that Colt.
 4 Q What type of Colt?
 5 A 1911.
 6 Q Okay, so a 1911 style Colt handgun?
 7 A Yeah.
 8 Q Okay. Did he tell you anything else?
 9 A No, that's it. He took off back home.
 10 Q Just that he was out cruising. Did he say anything
 11 about discarding evidence, hiding anything, moving anything?
 12 A No, he didn't say nothing like that. He didn't say
 13 that; he just said that you guys found the gun in his yard or
 14 something like that.
 15 Q Okay. Did he say anything about where he threw it or
 16 hid it or stashed it or just that we found it?
 17 A He just said you found the gun.
 18 Q Okay. Did he say anything else, admit to anything
 19 else?
 20 A He just said he was driving, he was drunk and he just
 21 seen that guy and he just started shooting.
 22 Q Did he say -- I mean did he allude to why he wanted to
 23 do anything like that? I mean most people just don't go
 24 around ...

1 Q Okay, so you guys were talking about types of guns and
 2 stuff.
 3 A Right.
 4 Q And then if you can remember what kind of lead into the
 5 shooting.
 6 A By him what he did that night, he was driving his car
 7 and he took his gun and shot out, shot at him.
 8 Q Okay. So he told you that he was wasted or got all
 9 messed up or whatever?
 10 A Yeah, he was drunk, yeah.
 11 Q Drunk, so he got all ... did he tell you how much he
 12 had to drink that night?
 13 A No.
 14 Q Just that he got drunk?
 15 A Yeah.
 16 Q And he was out driving around in his car?
 17 A Yeah.
 18 Q And was he looking for anybody particular did he say
 19 or --
 20 A No.
 21 Q Was he just looking for just somebody?
 22 A Drunk and stupid, seeing somebody running and he shot
 23 out.
 24 Q Okay. Did he tell up how many times he shot?

1 A He's drunk and he likes guns. He likes to shoot so ...
 2 I don't, you know, that's just ... he's young and he's dumb.
 3 Q Yeah.
 4 A He was just going out there shooting, being stupid.
 5 Q Right. So is there anything else that you can remember
 6 to the best of your memory?
 7 A That's basically what he said.
 8 Q Okay. So just to recap everything here. You guys
 9 were -- this conversation started evolving. You were talking
 10 about just guns in general and alluded to why he was locked up
 11 and the actions he did and that he --
 12 A Right.
 13 Q And he was driving around that night, he said he was
 14 wasted or drunk or something to that effect.
 15 A Right.
 16 Q Saw a jogger and decided to shoot at him more or less,
 17 something to that extent?
 18 A Right.
 19 Q And he said it was with some 1911, like a Colt style or
 20 something like that, a handgun?
 21 A Right.
 22 Q Did he tell you anything about a color of the handgun
 23 or anything else you can remember about the handgun?
 24 A No, he didn't say nothing.

- 1 Q Caliber, like 38, 40, 45 or something like that? He
2 didn't say anything?
- 3 A I thought he said that Colt ... I thought he said that
4 Colt gun that you guys found, but ...
- 5 Q Okay.
- 6 A But if that's ... I mean, you know, he said you guys
7 found a shell casing or something.
- 8 Q Yeah. So ... and then you said he went home and the
9 rest is history?
- 10 A Then you guys showed up, yeah.
- 11 Q Have you heard about anything Collin did before you
12 talked to Collin? Like is there anything circulating around the
13 jail or have you heard from any outside sources of what happened
14 over in our county?
- 15 A Just about that, and how he beat a case or something, a
16 rape. Something like that.
- 17 Q Okay, but I guess what I was trying to say is, is this
18 the first time you heard about the offense Collin did or did you
19 kind of know a little bit about it beforehand or is this all new
20 information to you?
- 21 A No, this is all new to me.
- 22 Q All brand new, okay.
- 23 A Yeah ... (Inaudible)
- 24 Q Right.

- 1 A He just started talking about it.
- 2 Q Right, and this is the first time you even met Collin,
3 correct?
- 4 A Right.
- 5 Q Okay. And with all that being said, is there anything
6 else you remember or want to add or anything else you want to
7 state for us while we're still on the recorder?
- 8 A No, that's about it.
- 9 Q Okay. Well, with all that we'll end it. It's roughly
10 15:40.
